The organisation carries out research, survey and monitoring and involves the community in wildlife activities; it runs an active Watch group for children and also has a small shop. - Responsible for financial control, and for quarterly progress and financial reports to the trustees; producing the annual budget, work plan and the annual report to auditors. The annual turnover is of the order of £400,000. Falklands Conservation obtains funding from a wide range of sources: annual subvention, membership, UK grants, donations, fundraising events, shop, etc..
- Preparation of the annual subvention request to the Falkland Islands Government (Falklands Conservation gets an annual grant through a Memorandum of Understanding); and responsible for grant applications for project work (e.g. Darwin Initiative, JNCC, Defra, EU BEST) and reporting back to grant-givers.
- Liaising with all those organisations with an interest in or involvement with the wildlife of the Falklands, both in the islands and the UK, whether statutory, commercial, public sector or NGO.
- Advice to trustees on the strategic direction of the organisation. Scrutiny of oil industry Environmental Impact Assessments & Statements.
- Project Manager for eight UK & Falkland Island Government funded projects, including species monitoring, invasive plants control and reducing conflicts between raptors and farmers.

- Setting up ecological survey and monitoring systems for the Trust's countryside properties, and carrying out Phase 1 habitat surveys of the NTS 75,000 ha landholding; managing contracts for specialist survey and monitoring work.
- Project work, including managing a £230,000 EU LIFE project, involving a partnership of NTS, SNH, James Hutton Institute (then Macaulay Institute), CEH (then ITE) & Scottish Wildlife Trust. This resulted in *Grazing Management Planning for Upland Natura 2000 Sites: A Practical Manual* (1998).
